




- Introduce the topic the workshop with a presentation of 5' minutes (the introduction has no standard format and has to be presented together by the two person in charge)



Rights ≠ Access

Human Rights:

- X Universal and inalienable.
- **×** Equal and non-discriminatory.
- ***** They are defined and protected by law.

Access:

- * Depends on resources available (ex. Financial).
- X No social or environmental priorities.





Human Rights ≠ Corporations Rights

Human Rights:

- ***** Social, civil, economic, cultural, political
- Applied to PEOPLE

Corporations Rights:

- X Intellectual Property Rights (patents, copyright)
- Applied to JURIDICAL ENTITIES and PEOPLE



United Nations Declaration on the Rights of Peasants and Other People Working in Rural Areas (UNDROP)

RIGHTS ACHIEVED by UNDROP





The Content of the Declaration:

- Art. 1: Definition of peasants and other people working in rural areas
- Art. 2: General obligations of States
- Art. 3: Equality and non-discrimination
- Art. 4: Rights of peasant women and other women working in rural areas
- Art. 5: Rights to **natural resources** and the right to development
- Art. 6: Right to life, liberty and security of person
- Art. 7: Freedom of movement
- Art. 8: Freedom of thought, opinion and expression
- Art. 9: Freedom of association
- Art. 10: Right to participation
- Art. 11: Right to information with regard to production, marketing and distribution
- Art. 12: Access to **justice**
- Art. 13: Right to work
- Art. 14: Right to **safety** and health at work
- Art. 15: Right to food and food sovereignty
- Art. 16: Right to a **decent income** and livelihood and the means of production
- Art. 17: Right to land and other natural resources
- Art. 18: Right to a safe, clean and healthy environment
- Art. 19: Right to seeds
- Art. 20: Right to biological diversity
- Art. 21: Rights to water and to sanitation
- Art. 22: Right to social security
- Art. 23: Right to **health**
- Art. 24: Right to adequate housing
- Art. 25: Right to education and training
- Art. 26: Cultural rights and traditional knowledge
- Art. 27: Responsibility of the United Nations and of other international organizations
- Art. 28: General Obligations



United Nations



Key Articles

Art. 1 Definition

Paragraph 1:

A peasant is any person who engages or who seeks to engage alone, or in association with others or as a community, in <u>small-scale agricultural production for subsistence</u> <u>and/or for the market</u>, and who relies significantly, though not necessarily exclusively, on family or household labour and other non-monetized ways of organizing labour, and <u>who has a special dependency on and attachment to the land</u>.




Key Articles

Art. 17 The Right to land

Paragraph 6:

States shall take appropriate measures to carry out <u>agrarian reforms</u> in order to facilitate the broad and equitable access to land and other natural resources necessary to ensure that peasants and other people working in rural areas enjoy adequate living conditions, and to limit excessive concentration and control of land, taking into account its <u>social function</u>. Landless peasants, young people, small-scale fishers and other rural workers should be given <u>priority</u> in the allocation of public lands, fisheries and forests.





Minimum requirements for respecting peasants rights to LAND by countries:

1. Need for a clear **overall land policy** (vision for future agriculture), created with the participation of the rural comunities, small family farmers, peasants, people working in rural areas and other right holders.

2. **Transparent and inclusive legislative process** and further **implementation process**, with focus on the rights holders – small family farmers, peasants and other people working in rural areas.

3. **Priority** (pre-emptive rights) to **young and small family farmers** when state land is leased out or privatized.

4. A **transparent land market information system**, accessible for rural communities and peasants

5. To **avoid speculation** in agricultural land (agricultural land should belong to farmers)

6. Limit the options for large corporate farms to own agricultural land (e.g. through max. allowed ha per natural person / company)

Key Articles

Art. 19 The Right to seeds

Paragraph 1:

(a) <u>The right to the protection of traditional knowledge</u> relevant to plant genetic resources for food and agriculture;


(b) <u>The right to equitably participate in sharing the benefits</u> arising from the utilization of plant genetic resources for food and agriculture;

(c) <u>The right to participate in the making of decisions</u> on matters relating to the conservation and sustainable use of plant genetic resources for food and agriculture;

(d) <u>The right to save, use, exchange and sell their farm-saved seed or propagating</u> <u>material.</u>

Paragraph 8:

States shall ensure that seed policies, plant variety protection and other intellectual property laws, certification schemes and seed marketing laws <u>respect and take into account the rights, needs and realities of peasants</u> and other people working in rural areas.






Minimum requirements for respecting peasants rights to SEEDS by countries:

1. **Protect peasants seeds** – heterogeneous material – from patents and copyrights and digitalization of genetic information for food and agriculture.

2. **Transparent and inclusive legislative process** and further **implementation process**, with focus on the rights holders – small family farmers, peasants and other people working in rural areas.

3. Allow peasants and farmers to use, exchange and sell farm saved seeds or propagating material produced at farms.





Other instruments that protect our peasants rights:

- 1. International Treaty on Plant Genetic Resources for Food and Agriculture (ITPGRFA)
- X Art. 9 Farmers Right to Seeds

2. New Organic Farming Rule of the EU:

Stipulations on right to sell seeds – heterogeneous material - produced by farmers themselves, certified in organic system

3. Voluntary Guidelines to support the progressive realization of the Right to Adequate Food in the context of the national food security






The real value of the implementation process for the Rights of Peasants will be determined by their contribution to changes in the lives and livelihoods of rural women and men around the globe, particularly the vulnerable and marginalized.

COLLECTIVELY building the process:


- 1. Awareness raising of authorities, peasants and the large public
- 2. **Capacity development** of peasants and small farmers organizations to defend their rights
- 3. Country level focus for building **inclusive processes** of participation in decision making, between governments and the small farmers organizations
- 4. **Partnerships, cooperation & coordination** in the society to support the voice of peasants and small farmers on a long term
- 5. **Monitoring and evaluation** of respect and fulfillment of the rights of peasants or the cases of violation and degradation of the rights of peasants






