


#### **Overall Project Status**

One of the many unsettling factors is the lack of certainty about almost every aspect of our lives as we are waiting to know how we will move out of lockdowns in the different countries. What this means for the project is that we are having to plan for different scenarios, and we are working together to come up with innovative solutions to problems that did not exist on this scale before the pandemic.

The BOND project is **on the final straight, only 6 months** to go and we hope that we can despite the difficult circumstances caused by the Corona crisis finalise the project successfully and in time.



The BOND project has accomplished at the **end of April 2020** the **26 deliverables** and **9 milestones** and **14** of the **deliverables** are already **approved**.

#### Project Highlights of the last months

#### **Workshop for Young Farmers in Norway**

The Norwegian partner NAC has organised on the 9<sup>th</sup> March 2020 in Oslo a workshop for young farmers with the title: **How to strengthen the agricultural cooperatives for the future?** From the 20 farmers invited 16 (6 female and 20 male) participated in the event.



## The Agricultural Cooperatives in 2030 - from the perspective of the young farmers:

- Leading the way to sustainable food production
- Financial stability
- A preferred choice for the farmers and the consumers
- Cooperation among farmers and cooperation among cooperatives, e.g. green technology
- Provides a network for the farmers
- Bottom-top decision making, not the opposite

#### **Policy recommendations - Preliminary:**

Sustainable food production

- Cooperatives taking the lead in achieving a sustainable food production.
- Involvement from food producers

#### **Strategic**

- Cooperation between cooperatives to take advantage of economies of scale where possible (e.g. technology)
- Strong cooperatives in the value chain for food

#### **Policies**

- Predictability in policy making
- Welfare programs, e.g. maternity/paternity leave and illness
- Equal competition frameworks for cooperatives and other company types



#### As the next steps it was planned to:

- Presenting the recommendations to the NAC Board
- Presenting the recommendations to the Minister of Agriculture and Food
- Newspaper article signed by the farmers
- Bringing the recommendations to the BOND Youth Forum



#### **BOND virtual Review session and Board meeting**

**6th Board meeting** was planned to take place in Prague, Czech, on 23rd April 2020 but due to the COVID-19 situation it was reorganised to be **two virtual meetings** for half a day on the 22<sup>nd</sup> and the 23<sup>rd</sup> April 2020 using Zoom.



**The first session** on the 22<sup>nd</sup> April was dedicated to review the outcomes and results of the following deliverables and activities that was finalised / happened before April 2020:

- Review D3.2 Set of recommendations and good practice on regulatory framework submitted Nov 2019
- Review D3.3 Four interactive regional policy roundtables on social capital and alliances
   submitted Feb 2020
- Review D4.4 8 Memoranda of Understanding on specific joint initiatives submitted Feb 2020
- Review Youth Event in Norway

**The second session** on the 23<sup>rd</sup> April was the official 6<sup>th</sup> Board meeting with the status review of the following ongoing and upcoming project activities and events:

- Status of the finalisation of the BOND Movie due to Oct 2020
- Status D4.5 Status of Youth forum due to Oct 2020
- Status D3.4 Lab Experiment in Moldova due to Sep 2020
- Status BOND publications due to Jun 2020
- Status M9 Dissemination & Communication due to Apr 2020

The Coordinator expressed her satisfaction about what the project has achieved and praised the consortium for it. The success of the project achievements proves how important it is that the EC continues to fund large networks of small and medium CSOs, and NGOs working grassroots and creating together such meaningful social innovation. It was a challenge to bring together such diversity and to decide at the start to be inclusive and not discriminate upon language (only those speaking English), thus allowing a much wider outreach. But the facts prove that the consortium was right to do so. Today "we have a BOND dedicated and active Board, and we succeeded to create a BOND dedicated and active community, where bonding has become part of the daily vocabulary.

Some partners raised the point to prolong the project to ensure that the Youth forum can be a face to face event. The Coordinator explained that the Corona crisis is reflected in a risked raised in the EC portal and reviewed regularly. It was agreed to wait and see how the COVID-19 topic and restrictions will evolve in the upcoming weeks and take a decision based on that.



#### Set of recommendations and good practice on regulatory framework

Under the deliverable D3.2 our Hungarian partner KLT has finalised a **Set of recommendations and good practice on regulatory framework** in cooperation with the other BOND partners. KLT has now prepared an **Executive summary** (English version attached to the newsletter) with the main findings which we would like to share with the broader BOND community and therefore we would like to know which the best languages are to translate it to.

### Project ongoing and upcoming activities of the next months

#### **BOND - Forum Young Farmers for the Future!**

The Youth Forum was postponed due to the COVID-19 pandemic.

In order to maintain the engagement with the confirmed participants, ECO has created the following Consultation process:

- Surveying all the participants on their vision and proposals over the future of farming in Europe (May 2020):
- Creating short web profile articles of all participants on the BOND website based on their survey answers (MAY 2020);
- Including all the participants on the BOND Facebook group and generating an online engagement with them (APR-MAY 2020);
- Holding 4 thematic online (ZOOM) workshops breaking the participants in 4 groups based on their interests and vision expressed in the survey (MAY 2020);
- Holding a webinar (ZOOM) at the end of MAY, presenting the outcome of the consultation process and key policy proposals that arise from the process;
- Publishing and disseminating a handbook/brochure "Young Farmers BONDing for the Future" with the testimonials of the participants and the main outcomes of the consultation process (JUNE 2020).



# Forum Young Farmers for the Future!

The international meeting, planned in the coming months, will gather together 34 young farmers and land managers (half female and half male) from 34 European countries.



The survey was already answered by 21 out of 34 farmers and we hope that we will receive the last replies soon so that we can share with all of you the profiles of the 34 young farmers and their inputs. At the moment it is hard to make an estimation about a new date for organizing the Forum in Romania, but the project still wants to make it happen.
